I. CALL TO ORDER

Members Absent: William Meier III, Peter DeBrino, Anne Cournoyer, and the Superintendent of Schools.

III. OLD BUSINESS

- a) Sanitarian/Health/COVID: Andrea Vitrano; Her report is attached. The fully vaccinated rate went down due to the new metric of "Fully Vaccinated" meaning vaccinations and boosters.
- b) Social Services: Alison Maynard; "Hidden in Plain Sight" will be at the Splash Pad grand opening event on Friday, July 8. Will hear if we will receive the Drug-Free Community Grant of \$125,000.00 per year hopefully in August. Allison is talking with neighboring towns to possibly partner for youth and resident mental health services. Community mental health needs continue to increase for both adult and youth residents.
- c) Police: Kim Littig; Introduced our new temporary Resident Trooper, Luke Davis. Dash cams were installed in all cruisers last week. There were a couple of installation issues. One has been resolved, working with our vendor on the other. There are two great candidates for the open SRO position. New England Tractor Trailer Training School reached out requesting a threat assessment. Police will be working with them on that. Pistol permit applications are still coming in at a high rate. Committals continue to be higher than typical.
- d) Fire: John Roache; John announced Ray Stovall has been promoted to Lieutenant. In general, our call volume continues to be high. We hired a new medic. It is summer so we

are seeing a high volume of motorcycle crashes. 18 new cadets have joined the Department. We received a grant for child car seat replacements and are working on a federal EFG grant.

e) Public Works: Todd Rolland; the month of June was quiet as far as storms/weather goes. DPW is in full summer operations. The Paul Bowers tournament was successful, with no issues. The summer concerts on the green are in full swing every Thursday night. The Splash Pad Grand Opening is Friday, July 8th (a Flyer is attached).

IV New Business

- a) CERT: Karen Hocking; Cert has been very busy the past month. Participated in the Paul Bowers tournament, conducting parking and traffic control. We've had members participate in the monthly paint care events at the Transfer Station, and the weekly concerts on the green. We held our monthly meeting/training in which we conducted a shelter operation overview. We will be conducting shelter training at the shelter during July's meeting. We will set up the shelter and go over shelter operations to familiarize new members with how it's done. CERT is holding a new member class on Saturday, October 15th, and Sunday, October 16th at the Fire Department.
- b) Todd Rolland introduced Dan Parisi our new Land Use Director.
