- Human Services programs have been working to draft or update and adopt a variety of basic tools to help improve data collection, record keeping, and to better gauge our impact.
- We recently developed a new standard client intake form to be used by all human services programs, a self-sufficiency matrix (a questionnaire to learn about needs beyond the presenting problem), a client satisfaction survey, and implemented enhancements to our database to streamline data collection and to eliminate redundancies and unnecessary data.
- A comprehensive Service Plan document has also been created and we continue working to finalize the department's first written policies and procedures.
- The department's first clinical policies and procedures for mental health counseling were drafted last year and will be reviewed by a clinical consultant.
- We have also implemented measurable performance metrics for all staff as part of the annual review and performance planning process, a major change from past practices.
- A number of staffing and membership changes on town commissions have also occurred: Officer Gerard Joyal will assume positions recently vacated upon Craig Jones' retirement, including Somers Comes Together, the Youth Services Bureau Advisory Board, and the Juvenile Review Board. Aiden Matthews, who joined us full-time a year ago as Youth Services Social Worker has resigned while on maternity leave.
- Upcoming priorities include the development and release of a Parent/Adult Community Survey to learn about community perceptions of need related to mental health and topics relating to mental health.
