- 1. Prepare, sand, and clean all surfaces for painting.
- 2. Repair small holes, cracks, and blemishes.
- 3. Apply two coats of Sherwin Williams Duration Interior Acrylic or equivalent finish.
- 4. All colors shall match the existing.

Auditorium Walls, Window boxes, and Frames:

- 1. Prepare, sand, and clean all surfaces for painting.
- 2. Repair small holes, cracks, and blemishes.
- 3. Apply two coats of Sherwin Williams Duration Interior Acrylic or equivalent finish.
- 4. All colors shall match the existing.

Auditorium Metal Doors, Frames, and Handrails:

- 1. Prepare, sand, and clean all surfaces for painting.
- 2. Repair small holes, cracks, and blemishes.
- 3. Apply two coats of Sherwin Williams Metal Oil Black or equivalent finish.
- 4. All colors shall match the existing.
